PEMAKLUMAN PENTING

Selamat datang kepada pelajar-pelajar baru dan selamat kembali kepada pelajar-pelajar lama!

1. Larangan pendaftaran kursus bertindih

Pelajar-pelajar **TIDAK DIBENARKAN** untuk mendaftar kursus bertindih pada slot yang sama (termasuk kursus ELC/TAC/CTU) **kecuali bagi kursus LAW533/LAW515**. Sebagai contoh- mendaftar kursus LAW497 dan LAW557 pada slot Sabtu 8.00-11.00.

Sekiranya didapati terdapat pendaftaran kursus bertindih, pihak iCEPS akan menggugurkan kursus tersebut. Penguguran kursus akan dibuat tanpa memaklumkan kepada pelajar, tanpa mengambil kira *preference* pelajar terhadap kursus tertentu dan tiada pemulangan yuran. Notis ini dianggap cukup dan munasabah untuk menafikan tanggungan pihak iCEPS di atas segala implikasi kewangan dan lain-lain implikasi yang dihadapi oleh pelajar- pelajar. Keputusan pihak iCEPS untuk menggugurkan kursus adalah muktamad dan tidak boleh dirayu..

2. Wajib mendaftar mengikut Pelan Pengajian

Pelan Pengajian Baru telah dilaksanakan bagi pelajar setara sepenuh masa (SS). Ini adalah selaras dengan keperluan untuk memastikan program ini kekal relevan dengan jangka masa pembelajaran yang lebih pendek (3-4 tahun) dan tamat dalam jangka masa maksimum 6 tahun untuk melayakkan mendaftar Certificate in Legal Practice (CLP). Ia juga bertujuan untuk memenuhi keperluan 120 jam kredit bagi program sarjana muda mengikut Program Standard Undang-Undang dan Syariah.

FOR HOLDERS OF BACHELOR OF JURISPRUDENCE (EXTERNAL) UNIVERSITY OF MALAYA & BACHELOR OF LEGAL STUDIES (HONS) (UITM):

A. A minimum of 5 credits at SPM level or its equivalent obtained in one and the same examination .

The qualifications which are accepted as equivalent to SPM are similar to the qualifications stated for U.K, Australia and New Zealand law degree holders.

AND

B. A minimum of 2 principal passes at STPM level or its equivalent obtained in one and the same examination . The duration of the STPM course or its equivalent shall be a minimum of 1 academic year .

The qualifications which are accepted as equivalent to STPM are similar to the qualifications stated for U.K, Australia and New Zealand law degree holders.

AND

C. A recognised law degree (see "[WHO HAS TO SIT FOR, & PASS, THE CLP EXAMINATION?](#)") which was studied for a minimum of 3 academic years and contain a minimum of 12 law subjects out of which you must have passed 6 core subjects (i.e. Law of Contract; Law of Torts; Constitutional Law; Criminal Law; Land Law; and Equity & Trusts which each was studied for the duration of 1 academic year). The Bachelor of Jurisprudence (External) from the University of Malaya must have been obtained within 7 years of initial registration with the university .

Bagi pelajar semester akhir yang berminat untuk mendaftar semula kursus pra-syarat (LAW531, LAW534, LAW510, LAW605) **dan** kursus LAW511, LAW581, LAW583, LAW585 di dalam semester yang sama, boleh memohon kepada Jawatankuasa Akademik Fakulti dengan mengisi kertas kerja dan mengemukakan melalui (email mazlifah414@uitm.edu.my) selewat-lewatnya pada **16 Mac 2023**. Jawatankuasa Akademik Fakulti ini hanya bersidang sekali sahaja pada setiap semester bagi tujuan permohonan ini. **Sebarang kelewatan di dalam mengemukakan permohonan tidak akan dilayan.**

Syarat Permohonan;

- a) Asas permohonan adalah masalah kesihatan atau urusan pekerjaan (surat sokongan majikan/kesihatan mesti dilampirkan);
- b) Telah mendaftar & menduduki peperiksaan akhir bagi kod kursus pra-syarat pada semester yang lepas;
- c) **Telah gagal atau mendapat kebenaran tidak hadir peperiksaan akhir bagi kod kursus pra-syarat;**
- d) Memperolehi CGPA 3.00 ke atas;
- e) Pelajar semester akhir (tidak melebihi 16 jam kredit); dan
- f) Jadual seminar tidak bertindan.
